
'OFOQ' is the new software interface to facilitate and streamline processes, allowing for e-payment, preclearance, authority approvals etc. and reduce overall lead times.

Kingdom of Bahrain offers a cost effective setup and operating for logistics businesses in the GCC, with company cost savings of 30-40% compared to its regional neighbours.





ZONE A - EXPRESS CARGO ZONE

Zone A is "Express Cargo Zone" and it will be built to provide infrastructure support for express cargo companies which require a rapid movement of goods in and out of facility and need services such as 24 x 7 Customs clearance, security, x-ray screening facility, as well as a dedicated cargo handler to manage their logistics requirements. This zone has access to the apron and has a clear demarcation between air and landside.



OPERATIONS

- Self-handling facility.
- Minimum security required at air and landside entrance or exit gate to allow tenants to load trucks at any time without Customs supervision.
- While moving goods from Zone A to B (Bonded facility) – cargo does not required a Customs clearance.
- Tenants would require Customs supervision when moving products from the landside to the airside.

- Rapid movement of cargo with airside and landside access.
- Each facility is of 2,500 SQM can be divided into two facilities.
- Provision of ground and mezzanine floor offices.
- 24/7 Customs services and rapid cargo clearance.
- A dedicated Ground Handling Agency.
- Individual loading and unloading area.







Ground floor can be optimized for retail shops that would support employees in the whole facility (restaurants, coffee shops).





